1. PREAMBLE

Born in 1990 and revived by WWF France in 2004, the MedPAN network brings together MPA managers in the Mediterranean and supports them in their management activities. Becoming an independent structure based in Hyeres (France), MedPAN association works with many strategic partners to achieve its objectives. The MedPAN Association is particularly partner with the Regional Activity Centre for Specially Protected Areas (UNEP-MAP-RAC/SPA) which has the role to validate the actions of the association and to support a number of activities especially within the MedMPAnet Project. The Association is also a partner of the WWF Mediterranean Programme Office and WWF France within the framework of the implementation of the MedPAN South Project and MedPAN North Project, respectively

The network became a legally independent structure at the end of 2008, aiming at promoting a sustainable network of marine protected areas (MPAs) managers. It acts to build the capacity of Mediterranean MPA managers through the exchange of best practices, training and the development of pertinent management tools.

To effectively respond to the needs of the network members and partners (38 members and 18 partners in February 2012), MedPAN, RAC/SPA and WWF-Mediterranean are planning to strengthen the MPAs creation mechanism along with the capacity building improvement of MPAs managers. This global approach has already started and is under way through the activities of the association and activities developed by the partners through MedPAN South Project (WWF Mediterranean), MedPAN North Project (WWF France) and MedMPAnet Project (UNEP-MAP-RAC/SPA).





The capacity building improvement has been already initiated, in particular trough training workshops organized on MPA management planning (Tabarka, Tunisia, 14-23 November 2009), planning for sustainable fisheries in MPAs (Kas, Turkey, 3-10 October 2010) and planning for sustainable tourism (Split, Croatia, 3-8 October 2011).

Finally, MedPAN Association, RAC/SPA and WWF-Mediterranean are planning to develop specific MPA management tools and guidebooks for more effective management of MPAs in the Mediterranean.



2. THE CHALLENGE

MedPAN Association, RAC/SPA and WWF-Mediterranean, in alignment with its partners, intends to define an overall framework for the development of future MPA management tools and guidebooks to ensure that these are fully adapted to the Mediterranean context and effectively respond to needs of the MPAs managers. A collection of future MedPAN guidebooks could be designed. A user-friendly internet interface will be then designed and established within the MedPAN official website for MPAs managers; practitioners and other relevant users could easily access all tools developed by MedPAN or its partners.

Many tools and guidebooks exist worldwide and have been produced to date by many international, regional, national and local institutions and organizations. Tremendous efforts have been made to that effect and products of high quality have been developed to date. However, despite this proliferation and the undeniable quality of these products, many returns reported very limited use of those tools/guidebooks by managers.

In 2010, MedPAN Association conducted a preliminary study with Mediterranean MPA managers to:

- Identify the management tools and guidelines for MPAs and PAs, existing in the Mediterranean but also in the world, in order to assess the gaps and the tools to be developed or adapted;
- Assess the use of these guides by MPA managers in the Mediterranean;
- Synthesize the priority topics for managers to develop or adapt the methodological tools;
- Set up 2010-2013 action plan for MedPAN Association.

The responses have drawn a mixed picture of the usefulness of these tools, generally considered as non satisfactory for one or many of the following reasons:

- Some MPAs already have adequate management plans;
- These documents are heavy, making them tedious reading;
- The language used in these documents is not necessarily accessible to all audiences;
- Or some interesting tools are not enough disseminated or promoted and are thus not well known or unknown.

As it is therefore difficult to adapt or improve existing tools/guidebooks, new ones tailored to the needs of the MPAs in the Mediterranean should be developed by MedPAN Association and its partners specifically.

This mission, subcontracted to the Cabinet Thétis Conseil and Pollen Agency, will lead to refine the assessment of MPA managers needs in order to define an overall framework for the development of future MPAs management tools and guidebooks, fully adapted to the Mediterranean context, along with the development of guidelines for the future website platform

This mission is coordinated by a Steering Committee including MedPAN Association, UNEP-MAP-RAC/SPA, WWF MedPO and other Mediterranean partner organizations¹, under the supervision of an advisory group composed of managers and experts

The mission will be undertaken, according to the three following steps:

- A first step to refine the assessment of managers needs for guidebooks/tools specific to MPAs,
- A second step to define procedures and criteria to develop guidebooks/tools which will serve to create MedPAN "collection"
- A third step to develop guidelines for the future website platform of MedPAN association

Parallel to the study on the development of management guides, WWF, RAC/SPA and MedPAN Association collaborate in the framework of another project to strengthen the capacity building of MPAs through a more integrated approach.

The project objective is to develop a strategy for capacity building meeting the needs of regional, national and local MPAs management in the Mediterranean. The study includes in particular the priority training needs of MPA managers. These results will serve as additional source of information for the present study on the development of management guides.

3. METHODOLOGY

The present study on the development of guidebooks for Marine Protected Areas managers in the Mediterranean is undertaken in the continuity of the work initiated by the MedPAN Association in 2010.

In order to take into account the needs of each manager for the development or the adaptation of management tools and to evaluate the impacts of these guides on the effective management of MPAs, MedPAN Association sent in April 2010 two questionnaires (one short and one long) to the Mediterranean MPA manager :

- The short questionnaire has been widely diffused to MPA managers in the Mediterranean (220 persons). The objective of this questionnaire was to collect rapid information on priority topics from a broad group of managers. Among 12 subjects, managers have to choose at least 3 priority topics of them (Annex 1).
- The long questionnaire has been sent to a target number of Mediterranean MPA managers (12 managers) involved since longtime in the MedPAN network in the North, East and South of the Mediterranean. The aim of this questionnaire was to get more detail on the expectations and needs of questioned managers (Annex 2).

Through these questionnaires, the MedPAN Association was able to collect and analyze responses of 23 managers for the short questionnaire (Annex 3) and 12 managers for the long questionnaire (Annex 4).

The present study on the development of management guides, subcontracted to Cabinet Thétis Conseil in partnership with Pollen Agency, allows continuing and deepening the study initiated by MedPAN Association in 2010.

A questionnaire had been prepared both in French and in English. On the basis of comments of the steering committee, the questionnaire had been finalized, validated and then transmitted to a sample of 20 managers and/or administrators of marine protected areas. 14 questionnaires have been indeed returned.

This questionnaire had been designed in order to check the results obtained by MedPAN in 2010 as regards the evaluation of the existing tools and guides and to assess the needs of the managers to improve their management capacity. The views of the managers and a panel of experts on the existing supporting materials and their proposals are necessary to improve the efficiency of future supporting materials for the best management of the MPAs.

This questionnaire refers to the supporting materials elaborated in other parts of the world and in the Mediterranean, in particular those already prepared by MedPAN and its partners.



This questionnaire is also dealing with all those aspects which will then make it possible to produce effective tools and guides in line with common expectations of managers or with due attention to geographical and cultural specificity, the MPAs specificities, the managers competence, etc.

This questionnaire (annex 5) had been elaborated as follows:

- A first item which allows to identify the person who responded to the questionnaire
- The second item deals with the general characterization of the MPA, its management staff and the main management challenges being faced
- The third assesses the relevance of the form and content of the existing guides. This assessment is not based on an existing list but rather on guides being able to score managers or that they remember
- The latter allows respondents to suggest topics among a range of themes selected on the basis of an existing list of management guides and also on the basis of other emerging topics that could be developed in management guides.

Three direct interviews with managers were carried out. They used to gather additional information on existing guides, their form, their content, the objectives managers advocate for practical and operational management guides and their suggestions to complement the guides.

The answers had then been analyzed so as to check whether there was a certain homogeneity between the MPAs, either through their characteristics or faced challenges, the experience of managers, their views on the content and the form of the existing guides and finally on the topics they think they should be developed in new guides.

The compilation and cross-checking of the answers received as well as a review of the main available management guides will make it possible to identify the most urgent topics to be developed, the form of the guides and the accompanying measures to be implemented.



4. RESULTS AND INTERPRETATION

Over twenty respondents, 14 have submitted their answers (annex 6).

While this sample is not statistically sufficient to treat the responses, however, it is enough to bring out the necessary outlines and guidance to build a new approach to the development of new guides or to the adaptation of the existing ones.

The responses have come from sites or countries equitably distributed throughout the Mediterranean and representative of the distribution of MPAs, respectively between western and eastern basins, between the north and the south shore and finally between European and non European countries.

4.1. MAJOR ISSUES FOR MPA MANAGERS

4.1.1. Issues related to MPAs

Almost all respondents (13 over 14) noted the presence of potentials/issues related to the presence of habitats, species but also cultural potentials of MPAs in which they are directly or indirectly involved (annex 7).

The *Posidonia* meadows and the coralligenous appear among the most cited habitats. A multitude of patrimonial species were cited especially *Posidonia oceanica, Pinna nobilis, Corallium rubrum.* 11 respondents out of 13 which indicated the presence of cultural issues, quoted in particular the presence of traditional fishing practices in their MPAs, confirming the importance of such practices in the Mediterranean and the need for their preservation.

4.1.2. Risks and threats on MPAs

The major risks are related to recreational activities, introduction of alien and invasive species, overfishing, illegal fishing and pollution problems, in particular the anthropic pollution. Those associated with trawling, overcrowding, civil and military maritime activities and harpoon fishing are mentioned at a second level (annex 8).

Moreover, one manager has drawn attention to the risk attributed to a very common practice in some countries of the south basin of the Mediterranean, which consists simply on the use of dynamite for marine resources fishing.

4.1.3. Emerging issues

As regards the emerging issues, there is an almost total agreement on the problems of the invasive species. In fact, while 11 over 14 questioned persons consider the biological invasions as a risk or a threat for their MPAs (previous section), 13 of these persons consider the biological invasions as an emerging issue (annex 9). This truly confirms the managers concerns about the vulnerability of the Mediterranean to biological invasions because of its communication with the Atlantic Ocean, both red and black seas, the intensive sea traffic and the lagoons and bays which had been invaded by fish farming and shellfish aquaculture.



Climate change appears also on the head of the major emerging issues in the Mediterranean. In accordance with the international community, the Mediterranean one is paying more attention to the problems related to climate change and gives them more dominant place on the environmental agenda.

4.1.4. Managers Knowledge improvement issues (cross-cutting issues)

4.1.4.1. Ecosystem Approach

Managers have mostly suggested all the topics that could be integrated into an ecosystem approach while we noted over the responses a less interest, though significant on aspects related to ecological corridors showing that the concern of managers is focused on their sites (annex 10).

4.1.4.2. Network Approach

Managers have mostly suggested that more attention should be paid to information exchange at regional level and a lesser degree to the establishment of databases. It clearly appears that improved knowledge of managers could be strengthened through the exchange within a network approach and the use of databases, which is in perfect harmony with the current and planned objectives and actions of MedPAN association (annex 11).

4.1.5. Conclusion on major issues

In this first section dedicated to the analysis of the emerging issues, it clearly appears that the main potentials of the Mediterranean MPAs are linked to the presence of habitats, species but also cultural potentials.

The major risks are related to recreational activities, introduction of alien and invasive species, overfishing, illegal fishing and pollution problems.

The major emerging issues of the Mediterranean MPAs are mainly linked to those related to the biological invasions and climate change.

The managers' concerns about the vulnerability of the Mediterranean to biological invasions is related to its communication with the Atlantic ocean, both Red and Black Seas, the intensive sea traffic and the lagoons and bays which had been invaded by fish farming and shellfish aquaculture. This points to the necessity to improve knowledge and research efforts, to improve understanding and awareness, to strengthen responses in terms of management and to reinforce appropriate legal and institutional mechanisms.

Climate change problems appear also among the major emerging issues in the Mediterranean. Its impact will continue increasing with time. By protecting the important habitats and ecosystem functions (such as the coastal carbon sinks), the MPAs could serve as the foundation for mitigation and adaptation strategies based on the ecosystems. Today more than ever before it is necessary to have an in-depth change in the way the MPAs are



designed, managed and regulated so that the main components of the marine ecosystems can adapt themselves to climate change.

Finally, it comes out from this analysis that the improvement of managers knowledge is more than necessary. It could be strengthened through the exchange within a network approach and the use of databases, which is in perfect harmony with the current and planned objectives and actions of MedPAN association.

4.2. USE AND ASSESSMENT OF EXISTING GUIDES

4.2.1. Known Guides

Most respondents (10 out of 14) confirm knowing certain existing guides they already used. The table 12 in annex summarizes and lists the existing guides used by respondents according to the specificities of their MPAs.

However, the topics of interest depend on the specificity of each area. Guides on the management and monitoring of scuba diving on the one hand and those relating to anchorages and moorings seem to be the best known.

4.2.2. Guides specifically developed within MPAs

Some MPA managers (4) have developed management guidelines specific to their MPAs (annex 13). These guides have been distributed either dedicated to internal use.

On the need to improve these specific guides, managers simply believe and recommend bringing more updates to reflect the progress of knowledge and techniques. They fully agree to share their management tools with the Mediterranean MPAs managers.

4.2.3. Relevance of existing guides

Through their responses, managers gave opinions on the guides dedicated to protected areas management. The responses have not been based on a specific list that would have been difficult to annotate, but generally on the basis of any document they know or they could use, regardless its source.

Although most of the respondents confirm they were driven by the need to consult management guides and that these management guides seem to be sufficiently accurate, their relevance in order to improve the proper management of MPAs does not meet significantly the expectations (annex 14).



This relative inadequacy of the specific management needs may explain the lack of interest to a large number of guides (except alright those they have produced to meet their own needs). Elements that justify this assumption are set out in more details in the table of the following chapter.

4.2.4. Causes of non use of existing guides

The above-mentioned findings were confirmed by the responses on the non-use causes of guides. In this context, the trends are quite clear and it appears that the main causes of non-use guides pertain to:

- Lack of dissemination and availability of management guides for managers of MPAs,
- Very complex implementation resulting from the lack of practical information,
- Inappropriate content to the local context.

This finding was confirmed through the direct interviews with three questioned managers (annex 15).

4.2.5. Assessment of the content and format of management guides

The responses leaded to make a general overview on the content and format of known guides by managers who answered the questionnaire (annex 16).

Broadly speaking, respondents reported that the content and format of existing and / or consulted management guides are good. If we rather refer to direct interviews, the following suggestions have been advanced to improve the guides:

- Further adapt the content to the Mediterranean even local context
- include more practical information and concrete examples for the best implementation, so that the contents can be directly used for management purposes
- Develop more attractive format, containing practical illustrations to facilitate, step by step, the implementation of the proposed actions and activities
- Link the guides to more iterative/Interactive tools which could be featured on the website of the MedPAN association (videos, photos, maps, GIS...) that allow either a better understanding of the guides contents, or the possibility to complete them.

4.2.6. Actions to improve the usefulness of guides

Accompanying measures to use the existing and planned management guides are a priority for the Mediterranean managers. These accompanying measures should include, in order of priority (annex 17):

- The development of a network of resource/key persons to be contacted
- The organization of field training sessions



- The organization of training workshops (which seems less prioritary than field sessions, according to the interviewed persons)

"It is important to consider that each MPA is a special case (bio geographical situation, legal systems and administrative staff, technical means...). Thus, the use of management guides as well as moving from theory to local practice often deserves special attention and technical support", reported the representative of the National Park of Port Cros.

Finally, responses from certain non French /English speakers stress the need to translate guidelines into their respective languages.

4.2.7. Conclusion on the assessment and use of existing guides

Given all the above, the analysis of responses looks a bit difficult considering that (i) some managers use tools only partially, (ii) others do not apply them to their MPAs and (iii) certain managers do not use tools and management guides. It is however sufficient to evaluate the usefulness and possible adaptation of the existing guides.

The methodological tools and management guides were developed so as to support the management of MPAs and are thus considered as essential tools for good management practices. They are directly dedicated to MPAs managers and/or other stakeholders in connection with these structures.

Although the existing tools and guides address different topics for the creation and management of MPAs, the relevance of these guides in order to improve the specific management of MPAs does not seem to meet the expectations of managers given the following reasons:

- Many tools are not well adapted to the Mediterranean or local (MPAs) context
- Many tools lack of practical information and concrete case studies for implementation
- Many tools lack dissemination and availability for MPAs managers
- Many tools are not iterative/interactive to serve as effective tools for awareness and dissemination
- Many tools are only available in English or in French
- Many emerging issues such as biological invasions and global changes are still not addressed or only beginning to be addressed at Mediterranean level

Accompanying measures to use existing and or planned management guides are a priority for the Mediterranean managers. These accompanying measures should be implemented in the following order of priority:

- The development of a network of key persons to be contacted to address some issues related to the management



- The organization of field training sessions serving as a test for the implementation of management guides recommendations (monitoring, restoring environments and habitats...) and to make managers more self-sufficient in the implementation of recommended methodologies and protocols
- The organization of more conventional training workshops, dedicated to treat conceptual aspects or aspects that do not require "field sessions" or simply organize additional sessions to field sessions when necessary, but not the contrary.

In the bulk, it is important to consider that:

- Each MPA is a special case and the use of management guides as well as moving from theory to local practice often deserves special attention and technical support.
- The MedPAN Association through its network of managers and its direct and indirect connections with its partners may proceed either to improve or adapt existing management guidelines and create new and relevant management guides.
- MedPAN network in collaboration with its partners could provide direct answers to the management needs of MPA managers, but also put forward solutions to emerging issues that will become major concerns in the coming years (e.g. global changes: invasive species, climate change).
- The MedPAN Association should be present to promote and facilitate this process and support managers in their approach and provide essential tools for good management practice.

4.3. MPA MANAGERS NEEDS

4.3.1. Issues to which managers do not have solutions

This chapter deals with the identification of issues to which the managers have no answers. Through their responses, managers put their finger on the priority issues to which they do not find entire or partial solutions and practical answers, despite the existence of a literature devoted to them.

The 7 priority topics are (annex 18):

- Socio-economic monitoring
- Funding and micro-funding for MPAs management
- Overfishing
- Illegal fishing
- Ecological monitoring
- Assessment of global change impact
- Regulation enforcement



Apart from the proposed issues in the questionnaire, three managers stressed other ones which they deem to be relevant for the marine protected areas as well as of general relevance:

- Support on global change, in particular climate change
- Sustainable development
- Coastal erosion
- Agricultural development
- Attenuated mode of transport (energy saving and low impact)
- Sustainable tourism
- Urban development and land-use management
- Choice of alternative and compensatory income generating activities
- Reflexion on adaptive and effective regulations
- Problems related to human resources (difficulty for public institutions/protected areas) to meet the staffing needs due to cyclical limitations
- Surveillance

The most often mentioned unresolved challenges are related to fisheries and monitoring (ecological and socio-economic). This highlights the urgent need to tackle fisheries problem as the imbalance resources-effort/demand is important. As regards the monitoring, it is mostly due to the multiplicity and specificity of the monitoring to be performed but also to the sparse documentation outlining concrete and operational approaches.

Less often mentioned but just as important are the MPAs financing aspects as well as the impacts of global change, still not well known as far as scientific community and managers are concerned and related documents are not operational enough.

4.3.2. Priority topics for MPA managers

Many suggested topics in the list provided to the managers within the questionnaire have been already developed in existing guides or books. Nevertheless, given the results of the first survey made by MedPAN Association which showed managers dissatisfaction towards the content and format of these documents, they were suggested again so that to evaluate the possibility to readapt them in order to meet the needs.

The priority topics (Annex 19) pertain to:

- Management of fisheries in general and specifically awareness and communication on sustainable fisheries
- Planning for sustainable tourism
- Surveillance at sea
- Environmental education in MPAs



- Monitoring in general, especially ecological monitoring including invasive species and monitoring of visitors
- Habitat management
- Sustainable financing in MPAs of MPAs
- Communication in MPAs
- Aspects related to environmental engineering
 - Restoration of fisheries resources
 - Eradication of marine invasive species
- Natura 2000 marine sites processes

If we compare these results with those arising from the 2010 MedPAN preliminary study and the first results of the capacity building strategy being developed (Annex 20), we notice firstly a similarity of results across MedPAN studies dedicated to guides and management tools and a certain disparity in the results with those coming out from the first stage of the capacity building strategy study.

The priority topics for the development or re-adaptation of management tools and guides are related to fisheries, tourism, environmental monitoring and police of nature, and the long term environmental education. Some similarities exist between these results and those arising from the strategy, but looking closer we see that the priority requests in the latter pertain mainly to conservation, fisheries and tourism which are the main factors of pressure and disturbance on this primary purpose.

The differences between the results of both studies and the strategy probably emanate from the following facts:

- The development of the questionnaires
- The respondents: a mixture between managers and institutionals for the strategy, managers mainly for the studies related to the guides and management tools. the results from the latter show the emergency faced by managers in the field, in more details through sub-topics,
- The context: Strategic for the capacity building study and operational for the studies dedicated to guides and management tools.

4.3.3. Conclusion on managers needs

It is important to mention that information exists for many mentioned topics. This information might be fragmentary or incomplete or included in some management documents. Some have already been developed in guides and management tools.



These topics had been raised anyway because managers feel reaching a deadlock: there is a lack of knowledge about available documents, missing or inadequate information (often on operational level), new challenges, context specificity and not mastered working language.

It is also necessary for each topic to respond pragmatically to managers needs, to provide them with information in the most optimal form and to coach them. It is also necessary to point out and introduce them to appropriate topics of local or global interest.

Explanations related to topics are reviewed below according to the level of responses recurrence in the questionnaire and therefore what may appear as a priority order.

4.4. SYNTHESIS OF AVAILABLE CONTENT FOR NEW GUIDES

Among the priority topics for managers, MedPAN Association and its partners have enough material to develop 20 guides. Three remaining topics have to be considered and planned.

In addition, MedPAN Association and its partners have also teaching content for the development of 3 other guides that have not been suggested by a majority of conservation actors in MPAs but are nonetheless relevant:

- Creation and management of MPAs
- Management effectiveness of MPAs
- Monitoring of marine mammals

The first two could be combined into a general guide dedicated to the management of MPAs. The guide dedicated to marine mammals could be included in the general collection dedicated to ecological monitoring (see Table 3).

It is also worth noting that in the framework of the MedMPAnet Project (UNEP-MAP-RAC/SPA), three guidelines were edited in the context of the Barcelona Convention and are being disseminated to decision-makers and managers of Mediterranean MPAs. Although these documents have not been prioritized by managers as part of this mission, it nevertheless remains important to report them since they have been requested by the Contracting Parties of the Barcelona Convention, in quite harmony with management issues.

5. RECOMMENDATIONS FOR FUTURE GUIDES

Methodological tools and management guides should be developed to support MPA management and thus should serve as crucial tools for good management practice. They should directly serve MPAs managers or other stakeholders in connection with these structures.

Even though existing tools and guides deal with various topics on MPAs creation and management, their relevance in order to improve the specific management of MPAs does not seem to meet managers expectations.

A review of existing literature and documentation leads to the following facts:

- Large number of documents deal with topics in connection with protected areas management in general, including MPAs
- Except MedPAN guides, most of existing guides consist of monographs, explaining or directing the management process. They are certainly useful as reference guides but very few guides focus on operational aspects. Even when operational content exist, it is often diluted in the document or is not precise enough
- Most of the documents are complex or too long and thus hard to read
- The documents are often written in one language only (English or French), sometimes in both languages.
- If certain requests concern existing documents, it does not show redundancies in terms of needs but simply show that these documents are not well known or not well adapted to the needs.

The list of guides/documents planned by MedPAN Association and its partners is perfectly in line with the most mentioned requests in the questionnaire. However, we see that the bulk of planned guides (as expressed in the responses) already exist (at least in the headlines and sometimes in the content).

on the other hand, we note that the requests for specific or operational guides are not completely in line with the list of proposed documents such as awareness and communication on sustainable fisheries, sea surveillance, management of marine habitats, spatial planning and technical tools (GIS, database), ways to restore fisheries resources, control and eradication of marine invasive species. They constitute practical topics that do not appear explicitly among the planned guides.

The elaboration of new guides and/or the adaptation or the updating of some of the existing guides must be in line with the expectations of the managers and should serve to improve the specific management of MPAs. The content and the format of the new tools and guides must ensure the following:

- They should be adapted to the Mediterranean context and specifically to MPAs (local context)
- They should contain practical information and concrete examples for implementation purposes



- They should be iterative/interactive to be used as an effective tool for awareness and dissemination
- They should focus on emerging subjects such as biological invasions and global change.
- They should be available in several languages.

It is also important to plan, apart from the general documents which evidently will be useful, guides meeting the requirements of manager job, so as to cover the following needs:

- To improve the contextual and general knowledge through concise documents which can be understood by all
- To meet especially the imperatives of knowledge improvement.

Accompanying measures to use the existing and planned management guides are a priority for the Mediterranean managers. These accompanying measures could be envisaged as follows:

- The development of a network of resource/key persons and/or institutions to be contacted (coaching and mentors)
- The organization of field training sessions
- The organization of training workshops

Thus, what is proposed as a process of capacity building (focused around the guides and tools) would be:

- To develop guides which meet the needs of managers, i.e. which should enable the best implementation of management imperatives,
- To develop, in a second phase, a campaign targeting managers to promote these guides and to allow managers discovering these guides but also discovering their usefulness and pragmatism, and finally
- The MedPAN network assists managers in a process of appropriation for the implementation of the guides/tools content either through actions promoted by the network or within the management programs of each MPA. To do this, the guides could be linked to other management tools to facilitate their content assimilation and that could be on the website of the Association (maps, interactive tools ...). The MedPAN Association can also count on a network of mentors/coaches specialized by theme and who could act as trainers of managers to initiate the implementation of each action on the field and if necessary within more conventional training sessions (indoors) for the benefit of the protected area managers and other managers.

Work perspectives during the next phase

General and specific measures to develop new guides will be established (such as adaptation and updating, translation of old guides, format and content of new guides). Mechanisms for the use of these guides and procedures of implementation will be identified in order to



create a positive synergy between these future documents and the necessary accompanying measures aiming at increasing their efficiency.

The following table summarizes the suggested measures to be planned within the forthcoming step to develop guidebooks by MedPAN Association and its partners. For that purpose, it is proposed to consider the following general recommendations:

- Adaptation of framing elements already existing and development of technical content adapted to real and operational needs as expressed by managers
- Translation into English, French, Arabic, Italian and Spanish
- Putting online related existing documentation
- Identification of coaches/mentors for accompanying actions
- Train the trainees

 Experience-sharing and capacity-building to improve the management of new/existing MPAs in the Eastern and Southern part of the Mediterranean;

- Communication on the project outcomes and achievements, and public awareness-raising.

MedPAN assessment of existing tools for MPA managers

Finally, MedPAN Organization, together with WWF-France, WWF-MedPO and RAC/SPA, is planning to develop specific MPA management tools and guidebooks for its members as well as the MPAs managers in the Med more in general.

Management tools and guidebooks, if correctly applied, can facilitate the work of MPA managers and contribute to a more effective management of their MPAs. Many tools and guidebooks exist worldwide on various topics related to MPAs creation and management of MPAs.

In 2010, MedPAN pursued the following actions:

- an inventory of the existing management tools /guidebooks for MPAs, and then more broadly for
 Protected Areas, in the Mediterranean and worldwide to assess which tools are missing or need to be
 developed or adapted for the Mediterranean MPAs
- an analysis of the use of the existing tools /guidebooks among MPAs managers in the Mediterranean to identify, which tools are being used the most and how such tools are applied to MPA management.

Generally, Med MPA managers use only part of the tools or they do not apply them to their MPA at all. This might be due to the following factors:

- The MPAs has already adopted an adequate management plan
- The inventory of management tools is quite long and the time needed to read through them might be prohibitive
- · Many tools are only available in English or only in French
- Some interesting tools are not disseminated or promoted

It is therefore difficult to adapt or improve existing tools/guidebooks. Thus, new tools/guidebooks should be developed by MedPAN Organization and its partners specifically tailored to the needs of the MPAs in the Mediterranean.

Potential topics for tools and guidebooks

To date, MedPAN Organization has identified the following topics (to be developed until 2013) (linked with MedPAN workshop):

- environmental education for MPAs
- alternative livelihoods and income generating activities
- climate change vulnerability assessment and climate adaptation planning.
- ecological and socioeconomic monitoring of MPAs.
- marine mammal management in MPAs with Accobams

Some tools developed in the framework of the INTERREG MedPAN project could be reviewed and improved.

The WWF-MedPO has already (or will soon have) material that can be easily developed into guidebook on (linked with MSP training workshops):

- MPA management planning (will be developed in link with the future guidelines developed by IUCN "How is your MPA managed")
- sustainable fisheries planning (may be developed with the MedPAN North project)
- sustainable tourism planning
- business planning/sustainable financing for MPAs
- marine spatial planning (zoning)
- communication for MPAs



The WWF France will develop, with its partners in the framework of the MedPAN North project, guidebooks onthe following themes:

- sustainable fisheries (link with MedPAN South project)
- tourism monitoring
- underwater trails

UNEP RACSPA will develop guidebooks on climate change; RAC/SPA will also develop in the framework of the MedMPAnet project some management tools depending on the top priority list of subjects that this study will give.

Other partners might join this initiative and develop other tools or guidebooks based on their resources and topic of Interest (Conservatoire du Littoral, Eurosite, EPASA, ECNC, Blue Plan).

Prior to the development of specific tools and guidebooks, the above list of potential topics will be shared with all MPAs managers and relevant authorities (Members and Partners of MedPAN, but not exclusively) for them to identify the top priority themes they would like to have a tool or guidebook on

2- Objectives:

The MedPAN Organization, in alignment with its partners, intends to define an overall framework for the development of future MPAs management tools and guidebooks to ensure that these are fully adapted to the Mediterranean context and effectively respond to needs of the MPAs managers. A collection of future MedPAN guidebooks could be designed. A user-friendly internet interface will be then designed and established within the MedPAN's official website (www.medpan.org) for MPAs managers, practitioners and other relevant users could easily access all tools developed by MedPAN or its partners.

Target audience; MPAs managers, practitioners and officials of relevant authorities/institutions in the 22 countries of the Mediterranean

Timeframe: 5 months

3- Implementation arrangements and partnerships;

MedPAN Organization will be responsible for the technical coordination of the study.

A Steering Committee including all interested partners will be established and chaired by RACSPA.  - ii) the list of existing MPA management guidebooks, tools and toolkits available worldwide (IUCN how is your MPA doing?, WIOMSA guidebook on MPA management....) and in the Mediterranean (INTERREG IIIC MedPAN project...).
 - iii) the material available as well as the guidebooks/tools planned in the framework of the partner's projects (MedPAN South and North projects, MedMPAnet, PIM initiative...),

The consultant(s) will then send the revised questionnaire to a representative sample of MPAs managers (identified by MedPAN organization and approved by the Steering Committee) in the region (and follow up with interviews) in order to:

- identify top priority areas of interest for the MPAs managers in the region
- assess the most suitable format for the final guidebooks/tools (the question of the needs for a translation of guidebooks in Arabic will be addressed also)
